WHEREAS, the founder of the Trust has set apart a sum of Rs. **1,000/- (Rupees One Thousand Only)** to form the nucleus fund of the above named trust and,

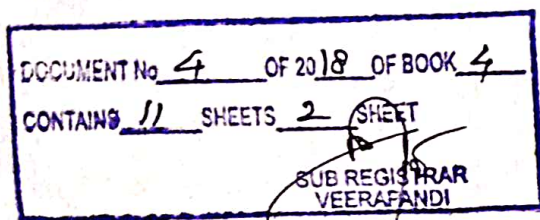
WHEREAS, the trust above named have agreed to accept the terms and conditions hereinafter appearing.

NOW THIS DEED OF TRUST WITNESSETH :-

1. The name of the Trust shall be **"VALLALAR EDUCATIONAL INSTITUTIONS"**.
2. The Registered office of the Trust shall be situated at **11/1, Vengampatty, Mallur, Salem District - 636203.**
3. The term Trustees shall mean the Trustees for the time being of **VALLALAR EDUCATIONAL INSTITUTIONS**. Consists of **P.VASANTHAKUMARI** W/o Ms.**PALANIVELU** residing at 11/1, Muthaliyar Street, Mallur, Salem-636203. Hereinafter called **FOUNDER CUM CHAIRMAN**.

ANUSUYA A.P. (Aadhaar Card No.9264 2403 6522) D/o. Ms. **PALANIVELU** residing at 11/1, Muthaliyar Street, Vengaampatty, Salem-636203, Herein after called **Secretary**.

Ms.**PALANIVELU** (Aadhaar Card No.5290 3128 5651) S/o **SENGODA GOUNDER** residing at 11/1, Muthaliyar Street, Mallur, Salem-636203. Hereinafter called **Treasurer**.

4. TRUST FUND MEANS:

- a. The Fund Contributed by the founder as corpus fund;
- b. All monies, investments and properties paid or transferred to and accepted by the Trustees as additions to the Trust Fund and
- c. The investments and property from time to time representing to such investments and addition accretion or any part or parts thereof.

5. OBJECTIVES OF THE TRUST:

The object of the "VALLALAR EDUCATIONAL INSTITUTIONS".

are those that are enumerated as Charitable under the provisions of the
Income – Tax Act of 1961 and Includes.

- a. To do services among the poor and downtrodden people so that their living condition and financial status may be improved.
- b. To start and run schools to give Basic, Primary and the Higher Education to the Villagers in remote parts and also to run technical / modern computer education to the poor boys and girls and physically Handicapped persons and to render financial and other help to the students and the Handicapped persons to continue their studies.
- c. To start cottage industry centers and medical cares to give opportunities to the people to raise their living conditions by undertaking cottage industries of all sorts and small – scale industries.
- d. To teach the people in bee keeping cattle rearing and poultry farming in order to raise their economical status.

e. To help those victims affected by natural calamities such as wind, rain, floods fire and epidemics, visiting the abandoned sick people in hospitals and visiting the prisoners in jail to help their family.

f. To teach the rural population to observe health and sanitary principles and to possible medical aid to the sick and ailing one.

g. And generally to do all other aid and help to the people who are socially economically and educationally backward based on the above objects.

h. To help poor and old people and widows in all possible ways and to run orphanages
The Trustees shall and will possessed of the said sum of Rs. 1,000/- (One thousand only) upon Trust and also of any other monies and properties which the Trustees may from time acquire or receive by way of gifts, donations or grants for augmenting the Trust and such donations or receipts may be accepted for the general purpose of the Trust or for any special or specific purposes connected with the objects of the Trust Indicated by the Donor.

All the funds, of the Trust and the income arising from the investments of the Trust funds shall be applied for the objects and purpose of the Trust in such manner as the Trustees shall from time to time decide at their meetings in accordance with the objects of the Trust.

8. CONSTITUTION:

The first set of Trustees shall consist of the following persons.

In addition, the trustees may from time to time include such of those persons whom they consider fit as Trustees by resolution and they shall become Trustees of the Trust as if they are made Trustees by these presents. If any time the number of Trustees is reduced to one, then such single Trustees can Co – opt one or more persons as trustees within the limit aforesaid, within a period of 3 months from the date of such reduction of the number of Trustees to one. If at any time the number of Trustees is reduced to nil, then a Competent Court of law shall appoint the Legal Heirs of P.Vasanthakumari as trustees of the Trust.

9. MANAGEMENT:

The day to day conduct and management of the affairs of the Trust shall be carried on by. **Anusuya A P – Secretary** who shall be known as the **Secretary**, she shall be the Managing Trustee till her life time or until she chooses her successor to be the Secretary.

10. THE MANAGING TRUSTEE SHALL HAVE THE POWERS AND DUTIES:

- a. To receive and keep all Trust funds and monies by way gifts, donations, voluntary contributions and grants and others assets of the Trusts. From India and abroad
- b. To acquire, sell, invest of any movable or immovable property.
- c. To borrow, lend, advance monies in furtherance of any activities of the Trust.
- d. To open bank accounts in the name of the Trust and to operate same.

(1) **Anusuya A P – Secretary** will operate the bank Accounts and Connected Transactions, This can be altered based on the Social resolution, passed, as and when required)

e. The Managing Trustee along with majority of the trustees shall have power to frame rules for the proper administration and function of the Trust.

f. The Managing Trustee along with other majority of the trustees shall be entitled to accept deposits and obtain loans and to invest the Trust monies and properties either with Bank or in other institutions, as prescribed under the Income Tax Rules.

g. The managing trustee shall record all the resolutions of the Trust Board Meetings and preserve the minute Book under his custody. Orphanages, to conduct eye camp, blood donation camp and medical camp, to receive donation from all over India and abroad.


While investing funds of the Trust, it shall not violate the provisions of the Income Tax Act 1961 under section 11 and 13, it is framed now, subject to such modifications, amendments or alterations to the Act that may be made in future provided further that no clause above said shall be construed as to permit the Trustees to violate the provisions of sections 11 and 13 of the Income Tax Act 1961.

11. The Trustee shall keep a true and correct account of all the Trust monies and the disbursements thereof and the accounts shall be made up to the end of the 31st of March each year and shall be audited by a practicing Chartered Accountants.

12. If for any reason the trustees feel that they cannot carry on the objects of the Trust themselves they shall transfer the funds of the Trust then available with its obligation and liabilities to any other Trust or Charitable Institution having similar objectives. The decision of the Trustees in this respect shall be final.

13. It is hereby expressly declared that the Trust is absolute and irrevocable.


